## CHANGING TODAY TO PROTECT TOMORROW

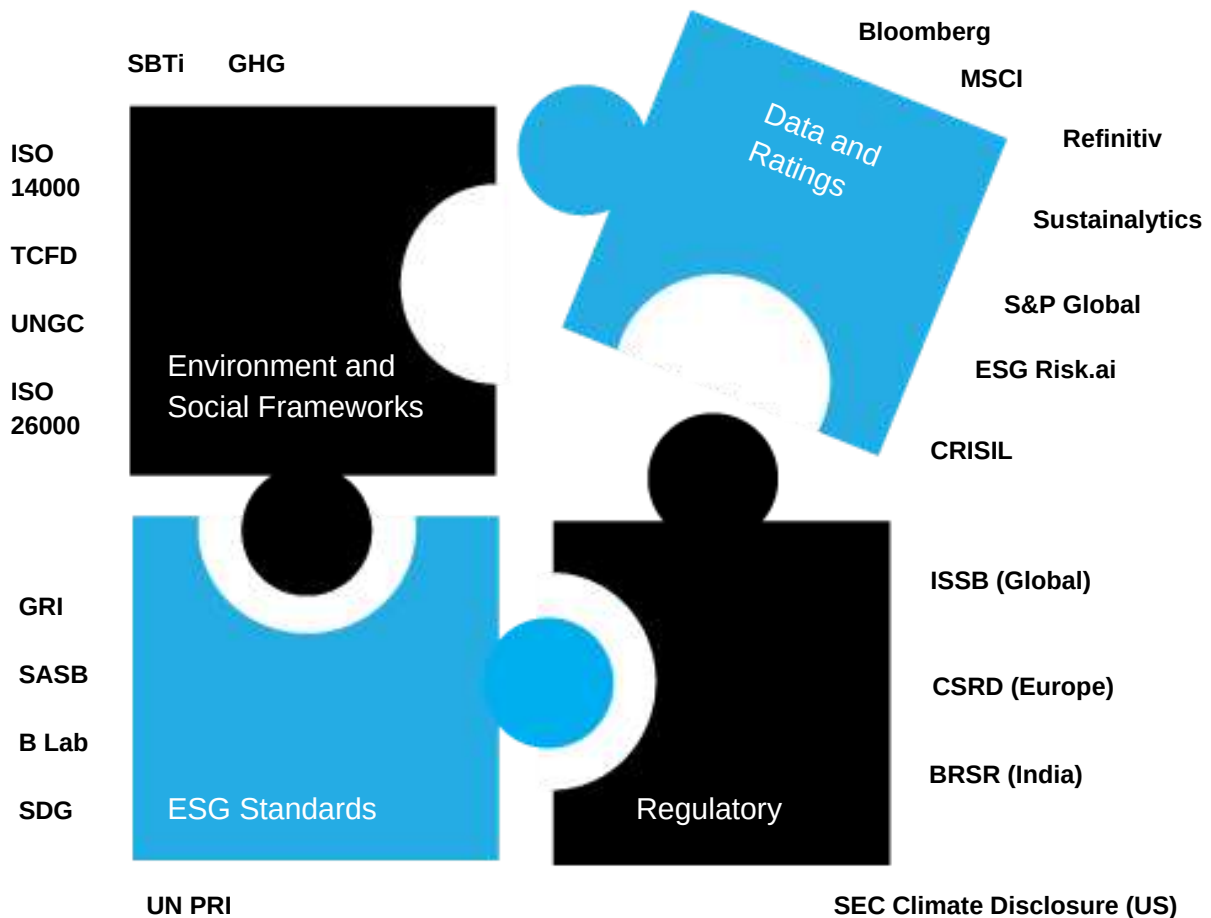

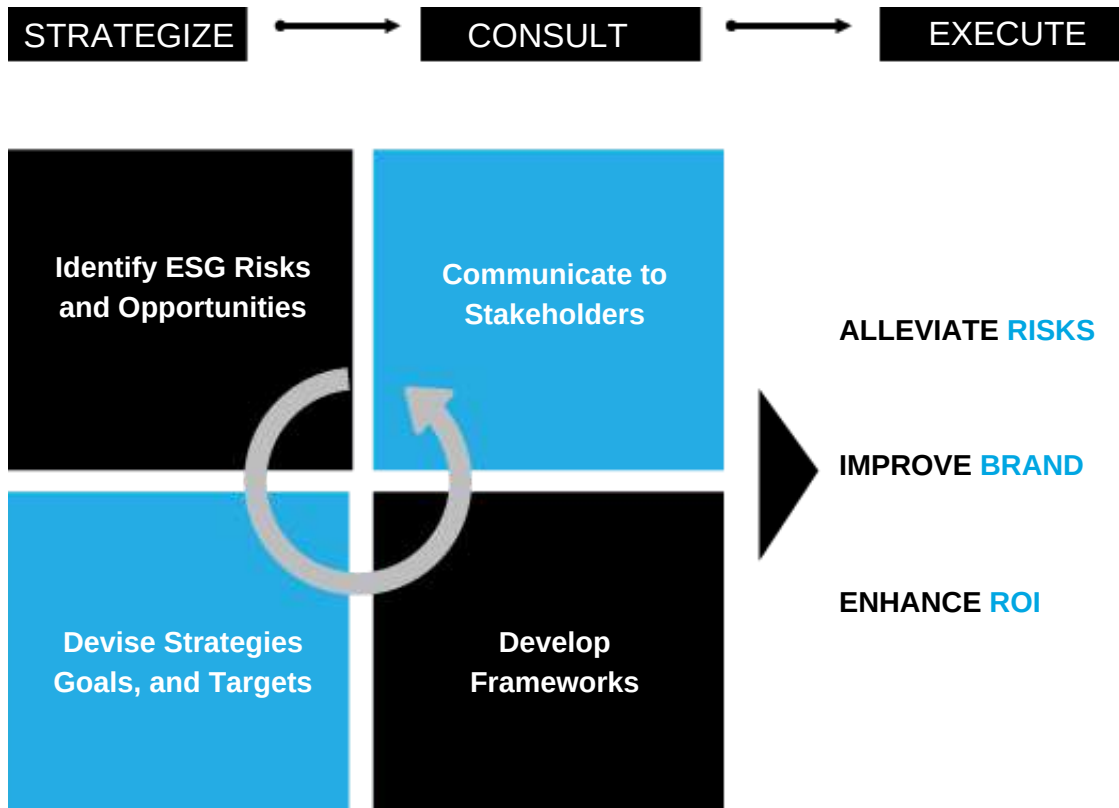


## NAVIGATING THE ESG ECOSYSTEM
